# Chair's Introduction



Welcome to the North Wales Tourism annual report 2020; little did I think that when I sat down during the first lockdown and set about writing the introduction to the 2019 report I would be in a similar situation 12 months later, but here we are!

The year has been a challenging one for our organisation, our members and our industry and the report for 2020 recognises the financial impacts of the pandemic on NWT as well as the work that has been undertaken by the team on behalf of our members throughout this difficult period. In many respects, the workload of NWT has increased during this catastrophic period when our members and our industry have needed us the most.

Whilst part of the organisation was furloughed - notably the distribution arm and the Tourists Information Centres - we continued to offer support and guidance as well as being a portal for the information coming from both Welsh Government and UK Government as well as the stream of guidance and legislation which accompanied the various lockdowns and re-openings. I know that for my own business, I have relied on the NWT members website for guidance at many stages of the past year and I know from communications from other members that this has been a lifeline for information, especially regarding the financial support the industry has received.

NWT has worked hard from the beginning of the current crisis to lobby elected representatives of all parties both at a National and UK level and ensure the voices of our industry and members are heard loud and clear. We have all learnt new ways to communicate and the power of technologies, like Zoom, have actually meant that we could improve lines of communication both within NWT and through engagement with our stakeholders. This has enabled us to be at the forefront as the voice for the tourism industry in north Wales and we have been persistent with organisations like the Welsh Government and Visit Wales.

Many members have adapted their business-model to navigate the difficult waters that the last year has brought and many have thrived as a result of these new challenges and opportunities; as we move to a recovery phase of the pandemic, I look forward to witnessing the extraordinary achievements of businesses within the industry.

We have been clear with stakeholders that, as we accelerate towards recovery (and re-opening for many), we must support businesses now to ensure jobs and livelihoods continue to thrive and grow and the hard work that has seen the incredible growth in tourism in north Wales pre-pandemic can recommence.


Tourism has been hardest hit during the pandemic being the first to close and almost last to re-open and NWT will continue to engage so that the road to recovery is a smooth one; I am mindful that too often, our industry has been used as something of a political football and we must continue to promote the industry as the economic powerhouse that it is here in north Wales. We should work hard with our communities, many of whom are our customers and employees, to engage in a positive way so that the benefits of the industry are equitable across the region. However, it is not acceptable to be consistently denigrated as an industry when our input across the region is so significant; we must all act as ambassadors for the industry to promote the benefits of sustainable tourism to our customers and communities. Indeed, sustainability must be a key component of everything we do as an industry going forward.

Our members are the backbone of NWT, and I would like to thank each individual member for their continued support and assure you that we will proactively promote our industry for your benefit and the benefit of all our communities across the region; as we now slowly emerge from the toughest times of the pandemic, I am confident that north Wales will once again be a formidable destination, world-renowned for its beauty, landscape, castles and coasts and we shall continue to thrive to offer a warm Welsh welcome to the many visitors from across the globe.



# Notes to the Financial Statements for the year ended 31 December 2020

## 1. STATUTORY INFORMATION

North Wales Tourism - Cwmni Twristiaeth Gogledd Cymru is a private company, limited by guarantee, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

## 2. ACCOUNTING POLICIES

### Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

### Turnover

Turnover is measured at the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes.

### Goodwill

Goodwill, being the amount paid in connection with the acquisition of a business in 2017, is being amortised evenly over its estimated useful life of ten years.

### Intangible assets

Intangible assets are initially measured at cost. After initial recognition, intangible assets are measured at cost less any accumulated amortisation and any accumulated impairment losses.

### Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.  
Plant and machinery etc - 25% on cost and 20% on cost

### Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

### Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. Current or deferred taxation assets and liabilities are not discounted. Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

### Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date. Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference. Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

### Hire purchase and leasing commitments

Rentals paid under operating leases are charged to surplus or deficit on a straight line basis over the period of the lease.

### Pension costs and other post-retirement benefits

The company operates a defined contribution pension scheme. Contributions payable to the company's pension scheme are charged to profit or loss in the period to which they relate.


Mae TGC wedi gweithio'n galed o ddechrau'r argyfwng presennol i lobio cynrychiolwyr etholedig o bob plaid ar lefel Genedlaethol a'r DU a sicrhau bod lleisiau ein diwydiant a'n haelodau yn cael eu clywed yn uchel ac yn glir. Rydym i gyd wedi dysgu ffyrdd newydd o gyfathrebu ac mae pŵer technolegau, fel Zoom, wedi golygu y gallem wella llinellau cyfathrebu o fewn TGC a thrwy ymgysylltu â'n rhanddeiliaid. Mae hyn wedi ein galluogi i fod ar flaen y gad fel llais y diwydiant twristiaeth yn Ngogledd Cymru ac rydym wedi bod yn barhaus gyda sefydliadau fel Llywodraeth Cymru a Croeso Cymru.

Twristiaeth sydd wedi cael ei tharo galetaf yn ystod y pandemig fel y cyntaf i gau a bron yn olaf i ailagor a bydd TGC yn parhau i ymgysylltu fel bod y ffordd i adferiad yn un llyfn.
